**AN ORDINANCE AUTHORIZING THE FINANCE DIRECTOR TO TRANSFER \$305,000 OF BUDGETED SALARIES AND FRINGES TO CONTRACTUAL SERVICES TO FUND THE SERVICES PROVIDED BY LAUTERBACH & AMEN LLP DURING FY 2018/19**

**WHEREAS**, the FY2018/19 Budget provided salaries and fringes for the administration of the Finance Department during FY2018/19; and

**WHEREAS**, most of those salaries and fringe costs were replaced with contractual service costs through the hiring of Lauterbach & Amen LLP to administer the Finance Department as delineated in Ordinance 2018-105 and Ordinance 2018-117; and

**WHEREAS**, at this time \$224,800 of Administration salaries and \$80,200 of Administration fringes can be transferred to Administration contractual services to fund this service in the appropriate account.

**NOW THEREFORE BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS: THAT** the Finance Director/Treasurer is authorized to transfer \$224,800 from Administration salaries and \$80,200 from Administration fringes and to transfer \$305,000 to Administration contractual services.
