

**RESOLUTION 2019-047**

**A RESOLUTION AUTHORIZING AND APPROVING THE EXECUTION OF A COLLECTIVE BARGAINING AGREEMENT BETWEEN THE VILLAGE OF VERNON HILLS AND THE ILLINOIS FRATERNAL ORDER OF POLICE LABOR COUNCIL (TELECOMMUNICATORS)**

**(TERM: MAY 1, 2019 TO APRIL 30, 2022)**

**WHEREAS**, the President and Board of Trustees of the Village of Vernon Hills, Illinois (the "Village") desire to enter into a labor contract for the employment of all full time Telecommunicators with the terms set forth in the attached "AGREEMENT BETWEEN THE VILLAGE OF VERNON HILLS AND ILLINOIS FRATERNAL ORDER OF POLICE LABOR COUNCIL (Term: May 1, 2019 to April 30, 2022)" (the "Agreement"), a copy of which is attached hereto as Exhibit "A" and made a part hereof; and

**WHEREAS**, The Agreement contains a three (3) year term from May 1, 2019 until April 30, 2022, and provides a wage increase of two and one half percent (2.5%) for each of the three (3) years; and

**WHEREAS**, the Village of Vernon Hills, a home rule Illinois municipal corporation, has the authority to approve and enter into the attached Agreement (Exhibit "A") pursuant to its home rule powers and contracting authority provided by Article VII, Sections 6 and 10(a) of the Illinois Constitution of 1970, as well as the Illinois Intergovernmental Cooperation Act (5 ILCS 220/1 *et seq.*) and finds that entering into the Agreement is in the best interests of the Village.

**NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1:** Each Whereas paragraph above is incorporated by reference into this Section 1 and made a part hereof as material and operative provisions of this Resolution.

**SECTION 2:** The President and Board of Trustees of the Village Vernon Hills authorize the approval and execution of the attached "AGREEMENT BETWEEN THE VILLAGE OF VERNON HILLS AND ILLINOIS FRATERNAL ORDER OF POLICE LABOR COUNCIL (Term: May 1, 2019 to April 30, 2022)" (the "Agreement"), a copy of which is attached hereto as Exhibit "A" and made a part hereof. The Board of Trustees further authorize and direct the Village President and the Village Clerk, or their designees, and/or the Village Manager, or his/her designee, to execute and deliver the final version of the attached Agreement, which may contain certain non-substantive and non-financial modifications that are approved by the Village Attorney, and all other instruments and documents that are necessary to fulfill the Village's obligations under the Agreement. The President and Board of Trustees of the Village of Vernon Hills further authorize the payment of all costs that are necessary to fulfill the Village's obligations under the Agreement.

**SECTION 3:** The President and Board of Trustees of the Village of Vernon Hills further authorize and direct the Village Clerk, the Village Manager and/or the Village Attorney, or their designees, to transmit executed originals or certified copies of this Resolution and the Agreement to all parties that are entitled to receive such documents.

**SECTION 4:** This Resolution shall be in full force and effect from and after its adoption and approval as provided by law.


