CONSTRUCTION OF A ROADWAY CONNECTION IN CONJUNCTION WITH CONSTRUCTION OF  
THE KINDERGARTEN FACILITY ON ASPEN DRIVE IN THE AMOUNT OF \$200,000 (TWO  
HUNDRED THOUSAND DOLLARS)**

**WHEREAS**, the Village of Vernon Hills (“Village”) is a home rule unit of local government as provided by Article VII, Section 6 of the Illinois Constitution of 1970; and

**WHEREAS**, at the November 28, 2017 Village Board Meeting, the Village Board authorized a contribution to Hawthorn School District 73 (the “District”) in the amount of Two Hundred Thousand and 00/100Dollars((\$200,000.00) to assist with the construction of a roadway extension in conjunction with the construction of the new Kindergarten facility on Aspen Drive; and

**WHEREAS**, on May 2, 2019, the Village approved a Site Development Plan for the construction of said kindergarten facility; and

**WHEREAS**, this amount was approved as part of the Village’s 2019/20 Municipal Budget; and

**WHEREAS**, construction of the kindergarten facility and roadway connection is largely completed; and

**WHEREAS**, payment to the paving contractor has been made by the District, and the District has submitted satisfactory evidence of such payment; and

**WHEREAS**, the District has now made a formal request for the Village’s contribution;

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

That the Finance Director for the Village of Vernon Hills is authorized to make a single payment to Hawthorn School District 73 in the amount of Two Hundred Thousand and 00/100 Dollars (\$200,000.00) in fulfillment of its commitment to the District for reimbursement of certain costs relating to the roadway extension supporting the District 73 newly constructed Kindergarten Facility on Aspen Drive.

**ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2020-053.




