AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO CDW FOR THE PURCHASE OF A 5 YEAR ANNUAL LICENSE AND SUPPORT AGREEMENT FOR VMWARE IN AN AMOUNT NOT TO EXCEED \$36,500

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village has implemented a virtual environment for much of its technology infrastructure, and

WHEREAS, that virtual environment is configured, operated, and managed by software provided from VMware, and

WHEREAS, to maintain licensing and support for the software, an annual support agreement is required, and VMware and HP provide the required support subscriptions, and

WHEREAS, the Village desires whenever possible to consolidate agreements and to create more efficient workflows, and

WHEREAS, the most beneficial agreement is a five (5) year, prepaid subscription offered by HP through CDW that brings all the Village licenses up-to-date and consolidates support under a single agreement, and

WHEREAS, expenditures over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents to purchase a five (5) year software maintenance agreement from HP through CDW at price not to exceed \$36,500.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to CDW in an amount not to exceed \$36,500 and is further authorized to immediately release payment to CDW for the VMware 5 year licensing and support invoice prior to appearing on the invoice approval list.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2020-064.




