

**VILLAGE OF VERNON HILLS
RESOLUTION 2020-014**

**A RESOLUTION GRANTING APPROVAL TO OPERATE OUTDOOR SPECIAL EVENTS
FOR MELLODY FARM LOCATED AT 849 MILWAUKEE AVENUE**

WHEREAS, Victoria Jacobson, representing Melody Farm, 849 Milwaukee Avenue has submitted an Outdoor Establishment permit application and plan for authorization to operate five special events in 2020; and

WHEREAS, the property, as described herein is located within the B-1, General Business District; and

WHEREAS, section 13.7.6 of the Zoning Code authorizes the Village Board to approve outdoor uses within the B-1 General Business District; and.

WHEREAS, the Board of Trustees, at their Committee of the Whole meeting on April 21, 2020, having fully reviewed and considered the request for the 2020 schedule of outdoor events, found that the application and plan sufficiently comply with section 13.7.6 of the Zoning Code and which, in its judgment, would justify it in recommending approval of the outdoor special events; and

NOW, THEREFORE, BE IT RESOLVED by the Village President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, that the Village of Vernon Hills will allow Melody Farm to operate five outdoor special events, conditioned upon:

1. The special events will take place in accordance with the 2020 schedule of events attached hereto as Exhibit A; and
2. All events are subject to compliance with the Governor of Illinois' standing order(s) regarding permission for certain business to operate, gatherings, social distancing and any other applicable order issued by his office; and
3. Written approval for each event shall be required from the Village Manager or his designee. Said approval shall be requested not more than one week in advance of each event; and
4. The Village reserves the right to require the hiring of two (2) off duty Vernon Hills police officers to be on site during the operating hours of the event. Melody Farm shall be responsible to pay the cost of the officers at a rate determined by the village; and
5. Compliance with the application and site plan dated March 24, 2020; and
6. Garbage receptacles shall be provided and the general vicinity shall be cleaned immediately following the event.




