**AN ORDINANCE AUTHORIZING APPROVAL OF PAYMENT TO ADVANCED
BUSINESS NETWORKS INC. FOR VILLAGE HALL STORAGE AREA NETWORK
UPGRADE PHASE 2 NOT TO EXCEED \$68,000**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (“*the Village*”) is a duly organized and existing municipality and unit of government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village uses Advanced Business Networks Inc. for information technology support; and

WHEREAS, the Village’s storage area network (SAN) at the Village Hall is in need of an upgrade; and

WHEREAS, Advanced Business Networks has ordered and will be installing the equipment needed to build the SAN; and

WHEREAS, all expenditures and purchases over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Advanced Business Networks Inc. in an amount not to exceed \$68,000 and authorized to immediately release payment to Advanced Business Networks prior to appearing on the invoice approval list.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2020-082.




