

**VILLAGE OF VERNON HILLS  
ORDINANCE 2020-107**

**AN ORDINANCE AMENDING CHAPTER 3, SECTION 3-12, PARAGRAPHS (1) AND (4) OF  
THE VILLAGE OF VERNON HILLS CODE OF ORDINANCES, RELATIVE TO LIQUOR AND  
LICENSE CONTROL AND ALLOWING THIRY-FIVE (35) CLASS "A" AND SEVEN (7)  
CLASS "D" LIQUOR LICENSES**

**WHEREAS**, the Village of Vernon Hills is a municipal corporation existing under the laws of the State of Illinois, and

**WHEREAS**, the Village, as a municipal corporation, has a duty to regulate the purchase, sale and serving of alcoholic beverages to the public for the protection of the public, health, safety, morals and welfare; and

**WHEREAS**, the President and Board of Trustees hereby adopt this ordinance amending the Liquor Control Ordinance of the Village of Vernon Hills pursuant to its duty to regulate the purchase and sale of alcoholic beverages within the Village of Vernon Hills;

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

SECTION I. That Section 3-12, paragraph (1) of Chapter 3, of the Code of Ordinances of the Village of Vernon Hills be and it is hereby amended to read as follows:

“(1) Class “A” License: A Class “A” liquor license shall authorize the retail sale of alcoholic liquors for consumption only on the premises specified. There shall not be issued at any one time any more than ~~thirty-three (33)~~ thirty-five (35) Class “A” liquor licenses in the Village”

SECTION II. That Section 3-12, paragraph (4) of Chapter 3, of the Code of Ordinances of the Village of Vernon Hills be and it is hereby amended to read as follows:

“(4) Class “D” License: A class "D" liquor license shall authorize the retail sale of beer and wine in food stores or other stores approved with the issuance of such license by the Liquor Control Commissioner of the Village. Such beer and wine shall not be consumed on the premises thereof. There shall not be issued at any one time any more than ~~five (5)~~ seven (7) class "D" liquor licenses in the Village.

SECTION IV. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications that are severable from the invalid applications shall remain in effect.

SECTION V. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION VI. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

SECTION VII. PUBLICATION. This ordinance shall be published in pamphlet for in the manner provided by law.


SECTION VIII. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2020-107.


