AN ORDINANCE AMENDING ORDINANCE NO. 2020-083, APPROVED JULY 7, 2020, WITH REGARD TO CORRECTING A SCRIVENER'S ERROR IN AN ORDINANCE APPROVING EXPENDITURES TO TYLER TECHNOLOGIES FOR THE PURCHASE OF NEW WORLD PUBLIC SAFETY ANNUAL MAINTENANCE AGREEMENT NOT TO EXCEED \$142,000

WHEREAS, the President and Board of Trustees of the Village of Vernon Hills (the "Village") approved Ordinance Number 2020-083, July 7, 2020, entitled, "AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO TYLER TECHNOLOGIES FOR THE PURCHASE OF NEW WORLD PUBLIC SAFETY ANNUAL MAINTENANCE AGREEMENT NOT TO EXCEED \$142,000" (hereinafter "Ordinance No. 2020-083"); and

WHEREAS, Ordinance No. 2020-083, within Section 2 "Authorization & Release of Payment", contained an incorrect amount of \$136,000, when said amount should have read \$142,000.

WHEREAS, it is in the best interests of the Village to correct said scrivener's error.

BE IT ORDAINED by the President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois in the exercise of their home rule authority, as follows:

SECTION 1: That Ordinance No. 2020-083 is hereby amended by correcting the following scrivener's error as contained therein:

Section 2, "Authorization & Release of Payment" shall read as follows:

"The Finance Director is hereby authorized to make payments to Tyler Technologies in an amount not to exceed \$142,000 per the attached invoice in Exhibit A."

SECTION 2: That all other provisions of Ordinance No. 2020-083, approved July 7, 2020, not corrected hereby, shall remain in full force and effect.

SECTION 3: That this Ordinance shall be in full force and effect from and after its adoption and approval as provided by law.

SECTION 4: This Ordinance shall be known as Ordinance Number 2020-120.


