

**VILLAGE OF VERNON HILLS  
RESOLUTION 2020-035**

**A RESOLUTION GRANTING APPROVAL TO OPERATE AN OUTDOOR SPECIAL  
EVENT FOR HAWTHORN MALL LOCATED AT 122 HAWTHORN CENTER**

**WHEREAS**, Thomas Sheehy, representing Hawthorn Mall, 122 Hawthorn Center has submitted an Outdoor Establishment permit application and plan for authorization to operate a special event for a drive in movie night; and

**WHEREAS**, the property, as described herein is located within the B-1, General Business District; and

**WHEREAS**, section 13.7.6 of the Zoning Code authorizes the Village Board to approve outdoor uses within the B-1 General Business District; and.

**WHEREAS**, the Board of Trustees, at their meeting on December 8, 2020 having reviewed and considered the request for an outdoor special event, found that the application and plan sufficiently comply with section 13.7.6 of the Zoning Code and which, in its judgment, would justify it in recommending approval of the outdoor special event.

**NOW, THEREFORE, BE IT RESOLVED by the Village President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, that the Village of Vernon Hills will allow Hawthorn Mall to operate an Outdoor Special Event, conditioned upon:**

1. The Drive in movie night will take place on Saturday, December 12, 2020.
2. The hours of operation shall be 6:30 pm to 8:30 pm.
3. All vendors, market management, and customers shall follow health protocols as provided in in the Restore Illinois Phase 3 Guidelines or current standing order from the Illinois Governor's office, whichever is more restrictive.
4. The mall shall employ a professional security service to monitor the event for compliance with these requirements
5. All vehicles shall be spaced a minimum 6'-0" apart.
6. Signs shall be posted at conspicuous locations encouraging 6'-0" social distancing.
7. All food vendors, market management, and customers are required to wear masks.
8. Individual food vendors are required to obtain a license from the Lake county Health Department

9. Compliance with the application and site plan dated November 19, 2020.
10. Garbage receptacles shall be provided and the general vicinity shall be cleaned immediately following each day of the event.


