

**VILLAGE OF VERNON HILLS  
RESOLUTION 2020-021**

**A RESOLUTION GRANTING APPROVAL TO OPERATE AN OUTDOOR MARKET FOR  
HAWTHORN MALL LOCATED AT 122 HAWTHORN CENTER**

**WHEREAS**, Sarah Phelps, representing Hawthorn Mall, 122 Hawthorn Center has submitted an Outdoor Establishment permit application and plan for authorization to operate a Makers and Artisans Market; and

**WHEREAS**, section 10-215 of the Village Code of Ordinances requires approval from the Village Board to operate an outdoor market; and

**WHEREAS**, the Board of Trustees, at their Committee of the Whole meeting on July 21, 2020 having reviewed and considered the request for an outdoor market, found that the application and plan sufficiently comply with section 10-215 of the Village Code of Ordinances and which, in its judgment, would justify it in recommending approval of the outdoor market.

**NOW, THEREFORE, BE IT RESOLVED by the Village President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, that the Village of Vernon Hills will allow Hawthorn Mall to operate an Outdoor Market, conditioned upon:**

1. The market will take place every Saturday and Sunday from September 5 thru October 11, 2020.
2. The hours of operation shall be Saturday noon – 5:00 pm; and Sunday 11:00 am – 4:00 pm.
3. All vendors, market management, and customers shall follow health protocols as provided in in the Restore Illinois Phase 4 Guidelines or current standing order from the Illinois Governor’s office, whichever is more restrictive. The Village reserves the right to rescind approval of the market if health protocols are not followed in accordance with State guidelines.
4. All vendors will be spaced a minimum 12’-0” apart. Hand sanitizer will be located at each booth
5. Signs shall be posted encouraging 6’-0” social distancing.
6. All vendors, market management, and customers are required to wear masks.
7. Individual vendors are required to obtain a license from the Lake county Health Department

8. Signage shall be posted at conspicuous locations encouraging social distancing and health protocols.
9. Compliance with the application and site plan dated January 30, 2019.
10. Garbage receptacles shall be provided and the general vicinity shall be cleaned immediately following each day of the event.




