

**VILLAGE OF VERNON HILLS
RESOLUTION 2021-015**

**A RESOLUTION GRANTING APPROVAL TO OPERATE AN OUTDOOR SPECIAL
EVENT FOR FANTASY AMUSEMENT COMPANY LOCATED AT 122 HAWTHORN
CENTER**

WHEREAS, William Johnson, representing Fantasy Amusement Company in cooperation with Hawthorn Mall, 122 Hawthorn Center has submitted an Outdoor Establishment permit application and plan for authorization to operate a carnival; and

WHEREAS, the property, as described herein is located within the B-1, General Business District; and

WHEREAS, section 13.7.6 of the Zoning Code authorizes the Village Board to approve outdoor uses within the B-1 General Business District; and.

WHEREAS, the Board of Trustees, having reviewed and considered the request for an outdoor special event at their meeting on June 1, 2021, found that the application and plan sufficiently comply with section 13.7.6 of the Zoning Code and which, in its judgment, would justify it in recommending approval of the Outdoor special event; and

NOW, THEREFORE, BE IT RESOLVED by the Village President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, that the Village of Vernon Hills will allow Fantasy Amusement Company to operate an outdoor special event, conditioned upon:

1. The carnival will take place from Thursday June 10 thru Sunday, June 13, 2021; and
2. The permitted hours of operation shall be The hours of operation would be: Thursday 6:00pm – 10:00 pm; Friday 6:00 pm – 11:00 pm; Saturday 2:00 pm – 11:00 pm; and Sunday 2:00 pm – 10:00 pm; and
3. The Village reserves the right to close off portions of Ring Road for the purpose of creating a pedestrian crossing.
4. All Fantasy Amusement Company staff are required to wear a mask during the entire operation of the carnival.
5. Fantasy Amusement Company is required to submit a list of all employees working at the carnival to the Vernon Hills Police Department at least seven (7) days in advance of the event.
6. Fantasy Amusement Company is required to hire two (2) off duty Vernon Hills police officers to be on site during the operating hours of the carnival. Fantasy Amusement Company shall be responsible to pay the cost of the officers at a rate determined by the village.

7. Compliance with the application and site plan dated May 4, 2021.
8. Garbage receptacles shall be provided and the general vicinity shall be cleaned immediately following each day of the event.


