

**VILLAGE OF VERNON HILLS
RESOLUTION 2021-021**

**A RESOLUTION GRANTING APPROVAL TO OPERATE AN OUTDOOR SPECIAL
EVENT FOR THE CHICAGO BEARS LOCATED AT 122 HAWTHORN CENTER**

WHEREAS, Cliff Stein, representing the Chicago Bears in cooperation with Hawthorn Mall, 122 Hawthorn Center has submitted an Outdoor Establishment permit application and plan for authorization to operate nineteen (19) outdoor special events; and

WHEREAS, the property, as described herein is located within the B-1, General Business District; and

WHEREAS, section 13.7.6 of the Zoning Code authorizes the Village Board to approve outdoor uses within the B-1 General Business District; and

WHEREAS, the Board of Trustees, having reviewed and considered the request for outdoor special events at their meeting on July 6, 2021, found that the application and plan sufficiently comply with section 13.7.6 of the Zoning Code and which, in its judgment, would justify it in recommending approval of the outdoor special events; and

NOW, THEREFORE, BE IT RESOLVED by the Village President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, that the Village of Vernon Hills will allow the Chicago Bears to operate nineteen (19) outdoor special events, conditioned upon:

1. The parking lot will be used from Thursday July 29 thru Thursday, August 26, 2021; and
2. The permitted hours of operation shall be: 9:00 am – 2:00 pm (July 28, 29, and July 31); and 8:30 am – 2:00 pm (August 2, 5, 6, 7, 8, 10, 11, 12, 16, 17, 18, 19, 23, 24, 25 and 26)
3. The Village reserves the right to close off portions of Ring Road and Mall Drive for the purpose of creating a pedestrian crossing(s).
4. The Chicago Bears are required to hire two (2) off duty Vernon Hills police officers to be on site during the operating hours of the event. The Bears shall be responsible to pay the cost of the officers at a rate determined by the Village.
5. Compliance with the application and site plan dated June 17, 2021.
6. Garbage receptacles shall be provided and the general vicinity shall be cleaned immediately following each day of the event; and
7. All Bears merchandise, including inflatables and portable signs shall be removed at the conclusion of each days event.


