ORDINANCE 2022-040**

**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO CURRIE MOTORS FOR THE PURCHASE OF THREE (3) 2022 FORD UTILITY INTERCEPTORS IN AN AMOUNT NOT TO EXCEED \$106,683**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, staff has delineated funds within FY2023 budget account (2103030-540020) for the purchase of three (3) police replacement vehicles; and

**WHEREAS**, said replacement vehicles will include three (3) 2022 Ford Utility Interceptors purchased through Currie Motors for an amount not to exceed \$106,683; and

**WHEREAS**, Currie Motors, 10125 W. Laraway Road, Frankfort, Illinois 60423 is an authorized Ford dealership that has been selected through a competitive bidding process to provide motor vehicles to municipalities participating in the Northwest Municipal Conference Suburban Purchasing Cooperative Contract #204 at the rate specified in the bid (contract); and

**WHEREAS**, Staff desires to place an order for said vehicles with Currie Motors within the month of April, 2022 since there is an extensive waiting period due to a delay in the manufacturing process of said vehicles; and

**WHEREAS**, all purchases over \$25,000 require Board of Trustee approval.

**NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute a contract with Currie Motors to commit the Village to purchase three (3) 2022 Ford Utility Interceptors in an amount not to exceed \$106,683; and

**SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT:** The Finance Director is authorized to process a purchase order and make payment to Currie Motors in an amount not to exceed \$106,683 for the purchase of three 2022 Ford Utility Interceptors; and

**SECTION 3: EFFECTIVE DATE:** This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

**SECTION 4: ORDINANCE NUMBER:** This ordinance shall be known as Ordinance Number 2022-040.






