

**VILLAGE OF VERNON HILLS  
ORDINANCE 2022-033**

**AN ORDINANCE AUTHORIZING EXPENDITURES OVER \$25,000 TO FLECK'S LANDSCAPING FOR THE 2022 GENERAL MOWING OF VILLAGE PROPERTY FOR AN AMOUNT NOT TO EXCEED \$95,630**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village is responsible for maintaining all Village-owned properties and Village rights of ways (ROW's); including lawn care and maintenance; and

**WHEREAS**, to do so efficiently and effectively, the Village contracts general mowing services for 40 locations throughout the Village; and

**WHEREAS**, Flecks Landscaping was awarded the 2021-2023 multi-year contract for General Mowing of Village Property with a base price of \$85,630 for all three years; and

**WHEREAS**, the Village has budgeted \$140,000 within the FY2023 budget account (0102047-520600) for both general and specialized contractual mowing, and

**WHEREAS**, a contingency of \$10,000 will be available beyond the base bid for extreme weather conditions; and

**WHEREAS**, expenditures over \$25,000 require Board of Trustee approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payment to Flecks Landscaping for an amount not to exceed \$95,630 within the 2023 Fiscal Year for the General Mowing of Village Property contract.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2022-033.






