



**AMENDMENT TO EMPLOYMENT AGREEMENT BY AND BETWEEN
THE VILLAGE OF VERNON HILLS AND JONATHAN PETRILLO**

THIS AMENDMENT TO THE EMPLOYMENT AGREEMENT (the "Amended Agreement"), made and entered into this 19th day of April, 2022, by and between the Village of Vernon Hills, an Illinois municipal corporation (hereafter called "Employer") and Jonathan Petrillo (hereinafter called "Employee").

WHEREAS, the Employer and Employee entered into an Employment Agreement (the "Employment Agreement") dated January 22, 2019, and

WHEREAS, the Employer and Employee desire to amend the Employment Agreement to the terms and conditions set forth herein.

NOW THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

SECTION 1. Definitions. Capitalized terms used in this Amended Agreement shall have the meanings assigned to them in the Employment Agreement.

SECTION 2. Amendments to Employment Agreement. Effective as of the date hereof, the Employment Agreement is hereby amended as follows:


(a) Section 6.e.: Vacation & Paid Time Off ("PTO") is hereby deleted in its entirety and replaced with the following:

Vacation & Paid Time Off ("PTO"): Employee shall be entitled to five (5) weeks of vacation annually. Employee shall receive an annual allocation of vacation time on first day January each year. Any vacation and/or PTO time remaining at the end of a calendar year shall be deposited into Employee's RHS account.


