**AN ORDINANCE TO ADJUST THE CURRENT SENIOR STAFF SALARIES IN
THE VILLAGE OF VERNON HILLS MANAGEMENT PAY SCHEDULE**

WHEREAS, the Village of Vernon Hills Management Pay Schedule (*“Pay Schedule”*) lists the corresponding salary ranges and salaries that are authorized for Senior Staff and is periodically reviewed to assess the compensation for Village employees; and

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2022-060.






