

**VILLAGE OF VERNON HILLS
ORDINANCE 2022-055**

AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO OMNI YOUTH SERVICES FOR THE PROVISION OF SOCIAL SERVICES AND FOR GRANTS DURING FISCAL YEAR 2022/2023 IN AN AMOUNT NOT TO EXCEED \$50,500

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village desires to provide social services for the residents of the community; and

WHEREAS, the Village has determined that Omni Youth Services is best able to provide social services to the community; and

WHEREAS, the Village has agreed to pay Omni \$39,000 for the provision of social services to the Vernon Hills community and an additional \$11,500 for a social service grant; and

WHEREAS, funds are available for these payments in the Police Department's Professional Services account (0103031-520540); and

WHEREAS, expenditures over \$25,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Omni Youth Services for the provision of social services and for grants during Fiscal Year 2022/2023 in an amount not to exceed \$50,500.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2022-055.






