

**VILLAGE OF VERNON HILLS
ORDINANCE 2022-056**

AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO KNAPHEIDE TRUCK EQUIPMENT COMPANY (FORMALLY R.A. ADAMS ENTERPRISES INC.) FOR THE PURCHASE OF TWO (2) 2022 SERVICE BODY WITH TOMMYGATE PACKAGES & ONE ADDITIONAL TOMMYGATE FOR AN AMOUNT NOT TO EXCEED \$35,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, funds are delineated in Fiscal Year 2022 budget account (2102040-540030) for vehicle purchases; and

WHEREAS, Ordinances 2021-114 and 2021-115 were approved by the Village Board authorizing the purchase of two 2022 Ford F250 Pickup Trucks and three 2022 Ford F550 Chassis Cab Trucks; and

WHEREAS, one Ford F250 Pickup Truck, and one Ford F550 Chassis Cab Truck purchased under said Ordinances need to be additionally equipped with a service body and TommyGate, and another of the F250 Pickup Trucks will also need to be additionally equipped with a TommyGate only; and

WHEREAS, Knapheide Truck Equipment Company, 2600 IL Rt. 120, McHenry, IL 60051, is an authorized truck and road equipment dealership who specializes in out-fitting trucks and chassis with service bodies and equipment; and

WHEREAS, Knapheide has been providing the Village with equipment and parts for vehicles and equipment for many years; and

WHEREAS, Staff seeks approval to have Knapheide Truck Equipment Company install two 2022 Service Body with TommyGate Packages, and one additional TommyGate for an amount not to exceed \$35,000; and

WHEREAS, all purchases over \$25,000 require Board of Trustee approval.

NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute the necessary documents with Knapheide Truck Equipment Company to purchase two (2) 2022 Complete Service Body with TommyGate Packages, and one additional TommyGate for an amount not to exceed \$35,000.

SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT: The Finance Director is authorized to process a purchase order and make payment to Knapheide Truck Equipment Company for the purchase of two (2) 2022 Complete Service Body with TommyGate Packages, and one additional TommyGate for an amount not to exceed \$35,000.

SECTION 3: EFFECTIVE DATE: This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

SECTION 4: ORDINANCE NUMBER: This ordinance shall be known as ORDINANCE NUMBER 2022-056.




