

**VILLAGE OF VERNON HILLS  
ORDINANCE 2022-067**

**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO FORCE AMERICA INC. FOR THE PURCHASE AND INSTALLATION OF THREE (3) SSC6100 SNOWPLOW AND SALT SPREADER CONTROL PACKAGES FOR AN AMOUNT NOT TO EXCEED \$36,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, funds are delineated in Fiscal Year 2023 budget account (0102044-520340) for equipment repairs; and

**WHEREAS**, Staff has selected three (3) heavy duty snowplow trucks (PW4, PW6 & PW12) to out-fit with advanced technology snowplow and salt spreader controls that will conserve on salt usage because of state-of-the-art electronics and more accurate calibration; and

**WHEREAS**, Force America Inc., 501 E. Cliff Rd, Burnsville, MN 55337, is an authorized truck and road equipment dealership who specializes in out-fitting trucks and chassis with hydraulic controls and equipment; and

**WHEREAS**, Staff seeks approval to have Force America Inc. install three (3) SSC6100 Snowplow/Salt Spreader Control Packages for an amount not to exceed \$36,000; and

**WHEREAS**, all purchases over \$25,000 require Board of Trustee approval.

**NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute the necessary documents with Force America Inc. to install three SSC6100 Snowplow/Salt Spreader Control Packages for an amount not to exceed \$36,000.

**SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT:** The Finance Director is authorized to process a purchase order and make payment to Force America Inc. to install three (3) SSC6100 Snowplow/Salt Spreader Control Packages for an amount not to exceed \$36,000.

**SECTION 3: EFFECTIVE DATE:** This ordinance shall be in full force and effect from its passage, approval and publication as provided by law.

**SECTION 4: ORDINANCE NUMBER:** This ordinance shall be known as ordinance number 2022-067.


