

**VILLAGE OF VERNON HILLS
ORDINANCE 2022-088**

AN ORDINANCE AMENDING ORDINANCE 2022-030 AUTHORIZING AN INCREASE IN EXPENDITURES TO CHICAGOLAND PAVING CONTRACTORS, INC. FOR THE 2022 BITUMINOUS PAVEMENT PATCHING PROGRAM FROM A NOT TO EXCEED AMOUNT OF \$100,000.00 TO A FINAL AMOUNT OF \$107,368.02

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village is responsible for maintaining all Village-owned properties, and Village rights of ways (ROW's); including public streets; and

WHEREAS, to do so efficiently and effectively, the Village contracts asphalt patching of damaged sections of pavement on various public streets on an annual basis; and

WHEREAS, ordinance 2022-030 authorized a second-year renewal contract with Chicagoland Paving Contractors, Inc. to perform said work; and

WHEREAS, staff delineated \$100,000.00 within Fiscal Year 2023 budget account (0209059-550050) for the 2022 Bituminous Pavement Patching Program; and

WHEREAS, the final cost of the work exceeded the not to exceed amount by \$7,368.02 due to the unanticipated Consumer Price Index increase of 6.5% in 2022 from 2021 and additional work areas; and

WHEREAS, staff seeks approval to increase the not to exceed amount to Chicagoland Paving Contractors, Inc. from \$100,000.00 to \$107,368.02.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to increase Purchase Order #70 to Chicagoland Paving Contractors, Inc. from \$100,000.00 to \$107,368.02, and make payment to Chicagoland Paving Contractors, Inc. in an amount not to exceed \$107,368.02.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2022-088.






