

**VILLAGE OF VERNON HILLS
ORDINANCE 2022-083**

AN ORDINANCE AUTHORIZING APPROVAL TO WAIVE THE COMPETITIVE BIDDING PROCESS AND AWARD A CONTRACT TO CERTAPRO PAINTERS TO PERFORM PAINTING AT THE PUBLIC WORKS BUILDING AND MUNICIPAL GOLF COURSE FOR AN AMOUNT NOT TO EXCEED \$56,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village of Vernon Hills owns and maintains multiple buildings and facilities including the Public Works Building and Municipal Golf Course; and

WHEREAS, staff delineated a total of \$56,000 within the FY2023 budget accounts 0102046-520600 (\$20,000) and 0209083-550030 (\$36,000) for contractual painting at said locations; and

WHEREAS, the scope of work for each location will include painting of the following areas; and

Public Works - Exterior: Flag Poles, Light Poles, Door Frames, Doors, Metal Beams, Stucco Trim, Dumpster Enclosure

Golf Course - Exterior: Cart Barn, Clubhouse, Gate, Fencing, Lightning Structure, Gutters, Shutters, Doors

WHEREAS, staff sought proposals from three contractors who specialize in professional painting services with CertaPro Painters providing the lowest proposals for combined amount of \$46,467.94; and

WHEREAS, CertaPro Painters has provided the Village with quality service in the past and has proven to be a reliable and dependable source; and

WHEREAS, a contingency amount of \$9,532.06 will be available for any unanticipated expenditures; and

WHEREAS, staff recommends the contract be awarded to the lowest bidder, CertaPro Painters; and

WHEREAS, expenditures over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all documents required for professional painting services to be performed by CertaPro Painters at the Public Works Building and Municipal Golf Course.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payments to CertaPro Painters for an amount not to exceed \$56,000.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2022-083.






