**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO  
ENTERTAINMENT MANAGEMENT GROUP FOR PAYMENT OF THE  
PRODUCTION SERVICES CONTRACT FOR THE 2022 VERNON HILLS SUMMER  
CELEBRATION**

**WHEREAS**, on February 4, 2020 the Village Board of Trustees approved Ordinance 2020-019, authorizing the execution of a contract for production services with Entertainment Management Group (“EMG”) in a not to exceed amount of \$89,500; and

**WHEREAS**, the 2020 services agreement with EMG was carried-over into 2021 and 2022 due to the cancelation of the 2020 and 2021 Vernon Hills Summer Celebration events; and

**WHEREAS**, a total of \$44,750 in deposits has been paid to date to EMG, which includes an additional \$2,500 deposit paid in 2021 to cover the band “Mike & Joe” for the canceled 2021 event; and

**WHEREAS**, the remaining balance due to be paid to EMG for the 2022 Vernon Hills Summer Celebration event is \$47,250; and

**WHEREAS**, expenditures over \$25,000 require Board of Trustee approval.

**NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND  
BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY,  
ILLINOIS:**

That the Finance Director is hereby authorized to make payment to Entertainment Management Group in an amount not to exceed \$47,250 for the remaining balance of the production services for the 2022 Vernon Hills Summer Celebration.


