

**VILLAGE OF VERNON HILLS
ORDINANCE 2022-090**

**AN ORDINANCE AUTHORIZING APPROVAL TO EXPEND FUNDS FROM
THE DRUG FORFEITURE FUND FOR THE PURPOSE OF EQUIPMENT
ACQUISITION NOT TO EXCEED \$9,500**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village of Vernon Hills maintains a Drug Forfeiture Fund, from which funds are used for the purposes of funding activities and equipment related to drug enforcement activities; and

WHEREAS, the need for this equipment was unforeseen and therefore not included in the current FY22-23 budget; and

WHEREAS, a payment from Drug Forfeiture Fund Account #1803030 530040 for an amount not to exceed \$9,500 is requested for the procurement of protective helmets and shields; and

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND
BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE
COUNTY, ILLINOIS, AS FOLLOWS:**

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:

The Finance Director is hereby authorized to release an amount not to exceed \$9,500 from Drug Forfeiture Fund Account #1803030 530040.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2022-090.






