ORDINANCE 2022-092**

**AN ORDINANCE AUTHORIZING PAYMENT TO WINDY CITY AMUSEMENTS, INC.  
FOR THE PROVISION OF THE FISCAL YEAR 2022/2023 SUMMER CELEBRATION  
CARNIVAL IN THE AMOUNT OF \$93,015.40**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, Ordinance 2018-114 authorized a five-year contract between the Village of Vernon Hills ("Village") and Windy City Amusements, Inc. ("Windy City") for the provision of the Summer Celebration Carnival; and

**WHEREAS**, the FY 2022/2023 required payment to Windy City is \$93,015.40 for the provision of the annual Summer Celebration Carnival; and

**WHEREAS**, all expenditures in excess of \$25,000 require Village Board approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Village Manager and Finance Director are authorized to make a payment to Windy City Amusements, Inc. for an amount of \$93,015.40 upon receipt of documentation of the amount due and payable for the Summer Celebration Carnival.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2022-092.






