**A RESOLUTION APPROVING A RAFFLE LICENSE AND WAIVER OF FEES FOR
VERNON HILLS HIGH SCHOOL COUGAR ATHLETIC BOOSTERS FOR HOME
GAMES THROUGHOUT THE 2022-23 SCHOOL YEAR**

WHEREAS, the Vernon Hills High School Cougar Athletic Boosters has submitted an application to operate raffles for home games throughout the 2022-23 school year; and

WHEREAS, Chapter 18, Article II, Section 18-39 of the Village's Code of Ordinances authorizes the Village Board to approve raffle licenses; and

WHEREAS, the Board of Trustees, at its meeting on August 16, 2022 reviewed and considered the application for raffles, found that the application sufficiently complies with the requirements of Chapter 18, Raffles and, in its judgment, would justify recommending approval of the raffle license.

NOW THEREFORE BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

That the President and Board of Trustees approve a raffle license and waiver of fees for the Vernon Hills High School Cougar Athletic Boosters to conduct raffles at Vernon Hills High School located at 145 N. Lakeview Parkway at home games throughout the 2022-23 school year conditioned upon compliance with Chapter 18 of the Village's Code of Ordinances regulating raffles.


