**A RESOLUTION APPROVING INTERVENTION IN PASSCO MELLODY FARM DST
TRUST TAX CASES**

WHEREAS, the Property Tax Appeal Board and the County Board of Review have determined by rule that a resolution is to accompany each Request to Intervene filed by an interested taxing body in any Property Tax Appeal Board and County Board of Review case; and

WHEREAS an adverse Property Tax Appeal Board or Board of Review decision as to the Passco Mellody Farm DST Trust will harm the Hawthorn Mellody TIF District in Vernon Hills (the "TIF District") in that it may result in a refund to be taken out of a subsequent levy.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, as follows:

SECTION 1: That the President and Board of Trustees of the Village of Vernon Hills hereby authorizes its administration and attorneys – Scott E. Nemanich and Klein, Thorpe & Jenkins, Ltd. - to intervene and take all necessary action in any Property Tax Appeal Board or County Board of Review case involving the Passco Mellody Farm DST Trust, Case No 2021 TX 00026, including filing Underassessment Complaints, as necessary to protect the interests of the Village and the TIF District.

SECTION 2: The Village President is authorized and directed to sign, and the Village Clerk is authorized and directed to attest to this Resolution.






