GOLF COURSE FROM REINDERS OF MUNDELEIN, ILLINOIS FOR AN
AMOUNT OF \$34,995.00**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village of Vernon Hills owns equipment for use at the Vernon Hills Municipal Golf Course; and

WHEREAS, the existing lawn mower deck has served its useful life; and

WHEREAS, the FY20-21 budget for the Vernon Hills Municipal Golf Course included a ProFlex Mower (\$23,000) and Golf Course Utility Vehicle (\$25,000); and

WHEREAS, Kemper has determined that the existing tractor will not meet the PTO of the new mower deck; and

WHEREAS, Kemper located a Used 2014 Groundmaster 4700 for \$34,995 that would meet their needs; and

WHEREAS, an immediate need exists for mowing versus the Golf Course Utility Vehicle that can be deferred until a future fiscal year and the proposed purchase is less than the \$48,000 budgeted.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all documents required with Reindeers of Mundelein, Illinois for the purchase of the used 2014 Groundmaster 4700 at the Vernon Hills Municipal Golf Course for an amount of \$34,995.00.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payments to Reindeers of Mundelein, Illinois for an amount of \$34,995.00

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2020-070.






