

**AN ORDINANCE AMENDING CHAPTER 3, ALCOHOLIC LIQUOR CONTROL, OF THE
VERNON HILLS CODE, SECTION 3-12, LICENSE CLASSIFICATION AND FEES, TO REVISE
THE REGULATIONS ASSOCIATED WITH THE CLASS "L" LICENSE IN THE VILLAGE OF
VERNON HILLS, LAKE COUNTY**

WHEREAS, the Village of Vernon Hills is a municipal corporation existing under the laws of the State of Illinois, and

WHEREAS, the Village, as a municipal corporation, has a duty to regulate the purchase, sale and serving of alcoholic beverages to the public for the protection of the public, health, safety, morals and welfare; and

WHEREAS, the Village Board approved Ordinance No. 2012-066 on December 18, 2012, which established the Class L license, for the purpose of permitting the online sale of wine for consumption not on the premises; and

WHEREAS, there are no businesses currently holding a Class L license; and

WHEREAS, the Village has received a request to modify the Class L license to expand the types of alcoholic beverages that can be sold online; and

WHEREAS, the Liquor Control Commission, at its meeting on November 1, 2022, discussed the requested amendment and directed Staff to prepare an Ordinance amending the relevant sections of Chapter 3, Alcoholic Liquor Control; and

WHEREAS, the President and Board of Trustees hereby adopt this ordinance amending the Liquor Control Ordinance of the Village of Vernon Hills pursuant to its duty to regulate the purchase and sale of alcoholic beverages within the Village of Vernon Hills.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:

SECTION I. That Chapter 3 Section 3-12 of the Village of Vernon Hills Code of Ordinances, Section, 3-12(12), Class "L" License is hereby amended to read as follows:

3-12(12) Class "L" License: A class "L" license shall authorize the online sale of ~~wine~~ **alcoholic beverages** not for consumption on the premises. Class "L" licenses shall be subject to the following conditions and limitations.

1. Customers are not permitted to purchase ~~wine~~ **alcoholic beverages** at the facility. Orders are required to be received via the internet, phone or mail, and **may be picked up or** shipped directly to customers.
2. The facility shall only be used as an office and for the warehousing of ~~wine and wine products~~ **alcoholic beverages and related products**.
3. Consumption of ~~wine~~ **alcoholic beverages** on the premises shall not be permitted.

4. Hours of operation shall be in accordance with Section 3-23 of the Liquor and Licensing Code.
5. Delivery shall require a signature from the recipient and shall be made only to individuals who are 21 years of age or older.
6. **Auctions conducted by the facility shall also be conducted online, and shall be subject to the State's auction license requirements.**
7. ~~6.~~ The business owners and managers shall be subject to criminal background checks and shall comply with the license restrictions set forth in section 3-7 of the Liquor and Licensing Code.
8. ~~7.~~ Not more than ~~zero~~ **one (1)** class "L" licenses shall be issued at any one time in the Village.

SECTION II. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION III. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION IV. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

SECTION V. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2022-118.




