INDEPENDENT AUDITOR'S REPORT ON COMPLIANCE

We have audited the **Village of Vernon Hills, Illinois**, (Village) compliance with the provisions of subsection (q) of Section 11-74.4-3 of the Illinois Tax Increment Redevelopment Allocation Act (Illinois Public Act 85-1142) applicable to the Village's **TIF #1 Vernon Hills Town Center Redevelopment Project** for the year ended April 30, 2022. Compliance with the requirements referred to above is the responsibility of the Village's management. Our responsibility is to express an opinion on the Village's compliance based on our audit.
