

**VILLAGE OF VERNON HILLS
ORDINANCE 2022-122**

AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO MORROW BROTHERS FORD INC. FOR THE PURCHASE OF THREE (3) 2023 FORD UTILITY INTERCEPTORS FOR AN AMOUNT NOT TO EXCEED \$126,825

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, staff has delineated funds within FY2023 budget account (2103030-540020) for the purchase of three (3) police replacement vehicles; and

WHEREAS, said replacement vehicles will include three (3) 2023 Ford Utility Interceptors purchased through Morrow Brothers Ford Inc. for an amount not to exceed \$126,825; and

WHEREAS, Morrow Brothers Ford Inc., 1242 Main Street, Greenfield, IL 62044 is an authorized Ford dealership that has been selected through a competitive bidding process to provide motor vehicles to municipalities; and

WHEREAS, Staff desires to place an order for said vehicles with Morrow Brothers Ford Inc. due to the order that was placed under Ordinance 2022-040 with Currie Motors in April 2022 for three (3) vehicles was canceled by Ford Motor Company in October 2022; and

WHEREAS, all purchases over \$25,000 require Board of Trustee approval.

NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute a contract with Morrow Brothers Ford Inc. to commit the Village to purchase three (3) 2023 Ford Utility Interceptors for an amount not to exceed \$126,825; and

SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT: The Finance Director is authorized to process a purchase order and make payment to Morrow Brothers Ford Inc. in an amount not to exceed \$126,825 for the purchase of three 2023 Ford Utility Interceptors; and

SECTION 3: EFFECTIVE DATE: This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

SECTION 4: ORDINANCE NUMBER: This ordinance shall be known as Ordinance Number 2022-122.


