**A RESOLUTION APPROVING A RAFFLE LICENSE AND WAIVER OF FEES FOR

WHEREAS, the Oak Grove School PTO has submitted an application to operate a one-time raffle for a fund raiser to be held on March 11, 2023; and

WHEREAS, Chapter 18, Article II, Section 18-39 of the Village's Code of Ordinances authorizes the Village Board to approve raffle licenses; and

WHEREAS, the Board of Trustees, at its meeting on February 21, 2023 reviewed and considered the application for raffles, found that the application sufficiently complies with the requirements of Chapter 18, Raffles and, in its judgment, would justify recommending approval of the raffle license.

NOW THEREFORE BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

That the President and Board of Trustees approve a raffle license and waiver of fees for the Oak Grove School PTO to conduct a raffle at Bowlero located at 316 Center Drive, Vernon Hills, Illinois conditioned upon compliance with Chapter 18 of the Village's Code of Ordinances regulating raffles.






